Clerk to seek a quote for hedge trimming at the Llanfair Discoed Play Area. Councillor Murphy will check the leylandii hedge report at the Trewen Play Area.

# M4919 PLACE PLAN REQUEST FROM PORTSKEWETT COMMUNITY COUNCIL To consider request in conjunction with information provided by Councillor Swift.

Councillor Swift advised that Planning Aid Wales can provide training in Place Plans at a cost of £600. This would currently amount to £200 for our Council. Council agreed, in order to investigate further whether a Place Plan is appropriate for us, that we partake in this training.

# **Caerwent Community Centre Lease**

Received confirmation from Solicitor of registration at Land Registry.

#### **Embrace Nature Caerwent**

Presentation from ENC made to Community Council on 30th July.

Council wrote to Cadw to inform them of revised plan.

ENC had written to Cadw requesting progress on the grant application as they are keen to start work soon.

Site meeting held with ENC on 17<sup>th</sup> August to look at preparing a Condition Report to send to Cadw – Clerk had sent her notes to ENC, awaiting some photographs from them

Seed scattering will take place shortly and residents will be invited to volunteer.

# Complaint Received Regarding Hedgerow Removal/installation of gates in Field on Shirefield Lane

Applicant advertising on Facebook Marketplace ".....land for sale with potential planning to rebuild the remains of the old cottage, planning permission granted for a tractor shed and double driveway gates. Lots of potential for numerous uses – caravans, log cabins or even a container home" even though permission had not been granted as yet. Agreed to inform Enforcement.

Highways objections had been posted on the MCC portal:

It should be brought to the attention of the applicant that a new or altered vehicular access being formed, the requirements of Section 184 of the Highways Act 1980 must be acknowledged and satisfied. In this respect the applicant has failed to notify the highway authority and has carried out works in contravention. The applicant is recommended to contact the highway authority to obtain the necessary permissions and agreement prior to removal of the access and reinstatement of the disturbed highway.

#### **New Website Accessibility Regulations**

Effective from 22<sup>nd</sup> September. The Chairman is currently building a new website which is partially compliant. New software had been purchased to enable this. Accessibility Statement had been drafted by Councillor Evans. Before the website goes live Councillor Evans will circulate a link to enable Councillors to view and comment.

#### **Provision of Allotments**

Information forwarded to Councillor Phelps from Councillor Murphy that technically allotments are horticulture which is classified as agriculture for which planning permission is not required.

However, any sheds and hard surfaces would need permission (and may also need SuDS if the hard surfaces are over 100 sq.m. Also, if a new access is required to serve the plots this may need permission off a classified road.

Councillor Phelps queried costs involved. Councillor Murphy agreed to seek information on current allotment plots within MCC.

## **Crick Flooding**

Councillor Swift reported that three MCC Officers had visited the properties affected on the A48 and Manor Farm and had spoken with the owners.

At the meeting MCC committed to clear blocked drains on the A48 and the hill towards Shirenewton (this action will be repeated in the future when appropriate); to create a channel through the footway adjacent to the northern parapet to the bridge in the middle of the village to allow standing surface water to drain into the brook; to mechanically sweep the road verges on the gradients which drain toward the village (this action will be repeated when appropriate); to resurface the A48 to reduce the amount of gravel being created due to surface breakdown which has been blocking the road drains. The actions are to be undertaken within a reasonably practicable timescale. It was accepted that MCC cannot prevent a build-up of debris from trees at all times.

#### **Manor Farm Adoption**

Councillor Swift reported that at a recent site meeting MCC Officers were of the view that Manor Farm cul-de-sac was not adopted. She advised that this is not the case and residents had provided evidence of this adoption previously to MCC. Councillor Swift had asked Councillor Murphy for his help with this.

## Village Hall Repairs

Downpipes and guttering appear to be fixed.

#### **Trees**

Following storm urgent request to Chairman for large branches to be removed from tree on Playing Fields as they were deemed dangerous – MCC removed.

Urgent request to remove large branch of ash tree at Community Centre – contractor removed.

# **Tree Survey (Trewen)**

Will be carried out shortly.

# **Toilets Covid Signage**

Clerk/Chairman placed Covid signage in toilets.

#### Re-opening of Community Centre/Village Hall

The Chairman advised that they can only open for essential services, ie election venues, youth clubs, play groups. Committees are currently working on risk assessment documents which this Council will have to approve before they re-open.

The Community Centre have almost finished their risk assessment documentation. They do not intend opening until mid October at the earliest.

#### Dog Waste Bin - Dualcarriageway west A48

Unable to obtain free bin from MCC as Keep Wales Tidy are no longer funding these. A dog bin could be purchased from Merlin Waste at a cost of £216 + £3.90 per week for emptying.

In the meantime we have asked via Councillor Murphy if MCC could provide a regular litter bin instead (to be emptied by them). Council agreed that if this is not possible to seek a cheaper dog bin.

# Letter Received from Twomlows 4th September

Twomlows advised that they have received correspondence from the Solicitor at Fields in Trust advising that the Deed of Dedication sent in by them should have been sent undated (not dated as per the transfer) in duplicate with signed plans. As only one copy of the deed was previously signed at the meeting and given the change of name of the organisation, Fields in Trust have requested that a new deed (including a plan) in duplicate is executed. When the Deeds have been countersigned by Fields in Trust, they will date the Deeds and return to us one completed copy which they will provide to us.

Clerk had arranged for Councillors Evans and Beattie to sign this documentation.

#### **Speed of Traffic, Crick**

Highways had confirmed that they were unsuccessful in securing funding from the Welsh Government to support the introduction of the various measures proposed. As such their internal capital budget will not allow them to progress all measures originally suggested but in the next couple of months (Covid permitting) they will be making arrangements to reduce the various speed limits along the A48, with Crick being included in this. They will also look into any gateway features that could be accommodated to remind motorists that they are entering/exiting a village.

Junction of Canon Lane and Caldicot Road - overgrown hedges.

Footpath from Caldicot Road to Playing Fields overgrown with wisteria, brambles, nettles.

Caerwent Brook - overgrown hedges.

East junction of A48 to Newport – overgrown trees/hedges.

Bridlepath at Five Lanes not maintained – Councillor Phelps will liaise with the Footpaths Officer regarding this.

Cwrt House Road requires road sweeper regarding fallen leaves.

Lane beyond Trewen Road to Cas Troggy Road in Llanfair Discoed has been closed for some time. Clerk received report back that this is due to its poor condition and an inspection by MCC will take place shortly.

#### M4924 REPRESENTATIVE REPORTS

Councillor Harris had received correspondence from the Education Achievement Service confirming that he had been appointed as a Minor Authority Governor for Shirenewton Community Council although he was unaware of this. He confirmed that he would be willing to take this on but just needed confirmation that this was accurate. Councillor Murphy will make enquiries and let him know.
