# **Dog Fouling Bags**

Clerk had established that the cheapest option would be an order through MCC at £35 per box (5000 bags). MCC will however have to persuade other Town/Community Councils to order at the same time as the minimum order is 20 boxes. The Council agreed to order five boxes but to also request that we still continue to receive the free supplies from MCC. Council were reminded that normal litter bins can also be used for dog waste.

In view of the fact that we are now funding this and the supplies run out very quickly, agreed to ask villagers in the newsletter to only take what they need.

# Dogs on Leads, Cadw land

Clerk had written to Cadw to point out their rules on their website regarding dogs but there is no actual signage on site. Cadw confirmed that they do have some signage which they will look into placing around the roman walls.

## **War Memorial Improvements**

Contractor waiting for a spell of good weather to complete the inscriptions.

# Replacement War Memorial Planters

The Chair had researched many suppliers and recommended that we purchase four Canadian redwood planters (55 cm H, 40 cm L, 40 cm W) at £66 each. These are maintained by use of a simple proprietary preservative spray a couple of times per year (spray bottle £17.50). The Chair advised that from the plant maintenance point of view there is a real benefit to the depth of the container as it will retain moisture much longer - and, being smaller in planting area than our existing troughs, will require less plants and maintenance. Council agreed.

# **Grant - Broadband Infrastructure**

No further progress. Councillor Murphy advised that negotiations are still ongoing with MCC and broadband companies.

# Defibrillator, Caerwent Village Hall

Councillor Haddow reported that British Heart Foundation grants are not available yet. She will keep enquiring.

# Defibrillator, Coach & Horses Public House

Councillor Haddow will be seeking permission from the Coach & Horses to relocate their defibrillator to outside. She enquired if the Council will be funding the outside cabinet and associated electrical works. Council confirmed.

Piece written by Councillor Evans and sent to the Institute of Welsh Affairs for inclusion in their new website. They will let us know when it is up and running. The Chair thanked Councillor Evans for preparing this.

### **Caerwent House**

Works allowed on the house but still halted on the land. Conservation Officer from MCC due to meet up with the Cadw Inspector this week.

# **Mounton House Closure Consultation**

Having consulted with governors of schools the following response was sent: Caerwent Community Council recognises the need to save money during this time of austerity and supports the proposal of MCC to close Mounton House to better deploy staff and financial resources. However, we can only do so as long as the mainstream schools, in particular Caldicot School, are not expected to accept these children with specific educational needs in their educational settings. The priority is that all children and young adults have the opportunity to reach their educational potential and that this is not negatively impacted by this closure.

### **Caerwent Show 2019**

Will be held on Saturday 17th August. All Councillors hoped to attend.

Councillor Harris advised that the British Heart Foundation will probably have a stall informing the public of defibrillators. The Caerwent Litter Champions are also hoping to have a stall.

# **Caerwent Litter Champions**

Councillor Harris reported that two more residents had joined the team. He is awaiting Keep Wales Tidy confirmation re paperwork and will then announce a date for the first Litter Pick.

# Village Hall Survey Recommendations

Councillor Murphy had chased this. MCC will be sending a quote for essential works.

#### **Drainage Survey**

Blockage is 60cm in from intersection chamber 3. Some pipes need cleaning before being surveyed. The two hour cost of the cleaning will be £180 for jetting and £140 for the camera. Following that they will then give a quote for what needs replacing. Agreed to cleaning.

# Village Hall Transfer

Repeated written/phone requests for update. Still no reply to our complaint. The Chair will look into have a meeting with them. The Clerk will send over the correspondence to him.

### Caerwent Toilets non-domestic rates

Checked with MCC. Although this was announced by Central Government in November 2018 it has not yet filtered down and been agreed by Welsh Government.
