#### M4874 APPOINTMENT OF CHAIR

Councillor Beattie (Chairman) had presented his apologies due to illness. The Clerk therefore called for nominations for the Chair position for this meeting. Councillor Haddow nominated Councillor Murphy, seconded by Councillor Swift. There being no other nominations Councillor Murphy was appointed Chair.

#### **M4877 PUBLIC PARTICIPATION**

Residents were extremely concerned about alleged drug dealing taking place from one of the properties on their street, exacerbated by speeding vehicles, driving under the influence, intimidation, movements during the early hours and a lack of respect for the home the alleged dealers live in, ie rats and mess present. Alleged dealing is taking place in the village and residents had repeatedly reported this to the police and to Monmouthshire Housing Association. Councillor Murphy advised that he had also contacted senior officers at MHA and the current situation is that the police are building up evidence for a case to be brought. Councillor Murphy, as County Councillor, is on several committees regarding the police and stated that he would raise this with them and with the Police and Crime Commissioner. Council agreed that action needs to be taken to improve the quality of life of residents on the street as the situation has escalated beyond the police action currently taken. Councillor Murphy requested that residents continue to report incidents/evidence but obviously taking their own safety into account. He will keep in touch with residents.

Residents were concerned about the speed of traffic on the Caldicot Road with one resident suggesting a petition to MCC. The Clerk advised that a new Speed Watch scheme has just been established and anyone interested should get in touch with her. Councillor Murphy requested that they write to him re this issue and he will take it up with Highways.

She had enquired if MCC could provide an up to date map but this did not seem possible. Councillor Beattie had volunteered to draw this up and send to our Solicitor.

# M4882 TO CONSIDER REPORT FROM CHAIRMAN ON MEETING HE ATTENDED REGARDING DOG FOULING

The Clerk reported that our Chairman had attended a meeting between MCC Officers and Town/Community Councils regarding the fact that there is only one option available for contracting dog waste collection and disposal, and the risk that this entails. The meeting was called to explore how the service could be delivered in the future and to make sure that there is a Plan B should one be needed. MCC reassured those present that if the current provider was unable to continue to provide a service then MCC would step in.

Many of the rural community councils have not experienced issues with their current service provider. They generally have less bins that are less heavily used than those in towns however the risks associated with having only one provider are relevant. The replacement of dog bins with litter bins would require more litter bins in rural areas particularly.

If more than one service delivery option becomes available, it should be noted that if councils chose different service providers there may not be enough work to make either service viable, hence the desire for all to work collaboratively

There are areas requiring clarification re current operation of the service. Community & Town Councils have a duty of care to ensure that the waste is being disposed of correctly.

Using litter bins to collect dog waste will prevent any litter from being recycled. Dog bins have the advantage over litter bins of being lidded, preventing smells and flies, however litter bins are emptied more often than dog bins.

The weight of dog waste will be counted as waste disposed of by Monmouthshire CC, so will adversely affect the recycling & waste statistics.

In the longer term MCC indicated that there are benefits in phasing out dog bins and use litter bins instead for dog waste. There is currently duplication of effort where there is a litter bin next to a dog bin. Collecting dog waste with litter will enable it to be incinerated along with household waste.

It is not currently known if the waste collected by Merlin is incinerated or put in landfill. Councils were asked to provide copies of contracts with Merlin if they have one.

Councillor Swift reminded Council that dog waste can be double bagged and deposited in general waste bins. Agreed that we could remind residents of this in the newsletter. The Clerk reported that a dog bin had been ordered for the Playing Fields through MCC but they have to wait for further orders to obtain a decent price. Still waiting for supplies of dog bags. One "No Dogs" sign removed already from the Playing Fields. There are three more which require removal. Illustration of new signage circulated. Agreed to order four for the Playing Fields.

### Boundary Review for Community/Town Councils in Monmouthshire

Update from John Pearson, Local Democracy Manager, MCC:

Until Welsh Government create an order for these proposals, they will not take effect, and then they will only take effect at the next set of ordinary elections due to take place in 2022. Its hopeful the order will be made asap as the Commission then need to undertake a review of the County Council ward boundaries and have this completed prior to the 2022 elections so that boundaries for the communities and counties are aligned for that election.
