M4778 MONTHLY POLICE REPORT

There was no police report.

M4779 LONELINESS AND SOCIAL ISOLATION PRESENTATION Rachel Rawlings/Joe Skidmore, Community & Partnership Development Team, MCC

The Chair welcomed Rachel and Joe to our meeting. Joe stated that MCC is the only Council in Wales to have a Cabinet Member for Social Justice. Loneliness and Social Isolation is an issue that can affect anyone at any age or stage of their lives. Feelings of loneliness have been shown to have wide-ranging consequences for those affected and have been shown to lead to depression across all ages.

They are developing a social justice plan where everyone has the opportunity to develop meaningful relationships regardless of age, status, circumstance or identity. It will seek to articulate a vision of the kind of Monmouthshire where community connections are increased and no one is excluded from participating in society for any reason. Whilst the local authority has an important role to play in creating the conditions for change to happen, everyone has a responsibility to help tackle loneliness and social isolation. MCC are committed to empowering communities to lead in this area.

Their team are currently in the process of mapping out what provision is currently available and they are looking to us to provide them with this information. Once this has been completed they will target where resources are required. The Clerk will collate a response.

Councillor George suggested that rural transport plays a large part in social exclusion. He also suggested that all schools should be consulted on this plan. Rachel informed the Council that MCC have already put in a bid to Govteach regarding rural transport and digital isolation. Councillor Swift was concerned about the lack of any volunteers and leaders for any projects. Councillors were encouraged to fill in the surveys which were handed out to help to shape the direction that the plan takes in informing local policy and partnership delivery.

To consider Asbestos Survey

Council noted that there was no immediate action to be taken.

To consider Drainage Survey

Council agreed that it was not very clear what the recommendations were. Agreed that we write back asking them to clarify and also to give us an idea of possible costs.

The Condition Survey had been sent by Councillor Murphy to an Officer in MCC to seek their views but he had received no response as yet. He agreed to chase this.

Clerk was asked to re-instate contact with Solicitor now.

M4783 REVIEW OF COMMUNITY ARRANGEMENTS IN THE COUNTY OF MONMOUTHSHIRE

To note report and recommendations from the Boundary Commission for Wales Council noted that The Commission has proposed amendments to our proposal based upon the existing electorate levels rather than projected increases. The Caerwent Community Council electoral arrangements will therefore be:

M4785 PROVISION OF DEFIBRILLATOR AT CAERWENT VILLAGE HALL To consider provision

Council agreed to seek advice from The Lions as to whether funding will be available for an external defibrillator at the Village Hall and if so to go ahead with the installation. Council agreed to fund the cost of a cabinet. Councillor Haddow will progress this.

Queries had been received regarding the internal siting of the defibrillator at the Coach & Horses pub. Agreed that it would be preferable for it to be placed externally

with 24 hour access. Councillor Haddow will contact the pub Landlords to discuss this.

Councillor Harris to report on progress

Councillor Harris reported that he now has 5/6 villagers interested in taking part. He had drawn up a risk assessment document, approved by the Council, which had been sent to Keep Wales Tidy. He is hoping for a Spring/Summer launch. He believes that the insurance costs could be approximately £105 per annum. Council agreed to cover this. Councillor Swift advised that he talk to Keep Wales Tidy as the insurance could be free in the first year and also that he seek advice regarding setting up a constituted group.

Precept of £56,000 for 2019/20 has been confirmed by MCC.

An application form for £250 funding had been received from the Caerwent Historic Trust for a magnetometer survey of field edge at outpost of Llanmelin Hillfort. Intend to use result to build support for a larger community based archaeological study at Llanmelin.

Council agreed, that as this enhances local historical links, to award the £250 requested. Council noted that The Historic Trust have also applied for £400 from the Welsh Church Fund – agreed that if there is a shortfall from the church fund that we would aid them further up to the amount required.

Council noted the Auditor General's conclusions.

M4791 HIGHWAYS/RIGHTS OF WAY

To consider proposal that Green Lane from the crossroads to Blackthorn House be recommended to Highways as a 20 m.p.h. route.

To consider proposal that Caerwent Road, from the crossroads to the A48 west junction, be recommended to Highways as a 20 m.p.h. route.

Council agreed to amendment

Council agreed that Councillor Harris seek a site meeting with either Paul Keeble or Graham Kinsella from Highways.

To report any highways/rights of way issues

St Tathan's road surfacing still not dealt with. Councillor Murphy will check on this.

Pot holes on Carrow Hill, Five Lanes, Old Shirenewton Road and junctions of Crick Road and Shirenewton Road.

Regarding the grass verge at the junction of the A48 and Five Lanes, an Officer of MCC would like to meet a Council member on site who can explain the history and reasoning. Councillor Swift agreed to search out the decision from MCC and then meet up with him.

M4792 REPORTS OF REPRESENTATIVES ON OUTSIDE BODIES

The Community Centre had received an application for Magor Scouts to book the Centre for an overnight indoor camp on 23rd February in order to obtain their Silver Dragon's Award. There will be approx 30 people in the group (both scouts and leaders). There will be no outside or late activities. The Chair of the Committee had confirmed that all insurances and safeguarding policies are in place.
